CALIFORNIA STATE RETIREES BOARD OF DIRECTORS MEETING MINUTES Zoom February 11, 2022

1. Call to order

The meeting was called to order at 1 p.m. by President Stephanie Hueg.

2. Salute to the Flag

The pledge of allegiance to the flag was led by Vincent Herrera.

3. Roll Call

Members present were:

4. Ground rules

President Hueg covered ground rules for the meeting: be respectful and use a respectful tone, raise your hand to speak, a list will be maintained by the moderator, one comment per topic until others have had the chance to comment, do not interrupt, keep comments short and to the point, try not to repeat, stay on topic.

Added Items

The Board reviewed summary of motions from January 20, 2022; there were no comments nor changes.

Herrera added a Health Benefits Committee (HBC) recommendation and reported on the Medicare Direct Contract Pilot Program. HBC chair, Larry Woodson, joined for the discussion. Motion passed to authorize a letter to be sent to US HHS Secretary Xavier Becerra. This letter falls under grass roots lobbying efforts; CSR will still have the letter reviewed by outside counsel to ensure no lobbying laws are violated.

President Hueg will ask the HBC to report on Mark Cuban's pharmacy endeavor at the March HBC meeting.

CSR 3/22/1: Herrera, second by Behrens to send a letter, signed by President Hueg and cc to CalPERS, to US HHS Secretary Xavier Becerra and key congress members identified by President Hueg, Rocco Paternoster, Ted Toppin and Corinne Celentano, to halt the Medicare Direct Contract Pilot Program. CARRIED

5. Remote work data plan request

The Board discussed and established a \$25 monthly stipend for the committee chairs. The monthly stipend for committee chairs will be charged to the applicable committee line item.

CSR 4/22/1: Herrera, second by Franklin to give committee chairs a \$25 monthly stipend. CARRIED

6. CFO report

CFO Fountain presented his observations at recent visits to chapter meetings; chapter gift card giveaways; travel expense claims (TECs) not being turned in timely; and chapter financial concerns. Gift cards are a problem in two (unidentified) chapters. The District Directors of these two chapters will have a discussion with the chapter officers regarding CSR's gift card policy. President Hueg directed CFO Fountain to give a gift card policy refresher report and TEC policy reminder report at the March Board meeting. The amount of funds given away through donations and giveaways need control parameters put in place. CFO Fountain to work with the Finance chair, David Okumura.

CSR 5/22/1: McDonnell, second by Jimenez to have the Finance Committee look at the amount of funds being given away through chapter donations and giveaways. CARRIED

7. Chapter visit update

CFO Fountain reported on the findings from recent chapter visits, noted financial issues with handling of membership funds. A team of three was appointed by the Board to do a fact finding trip to listen and discuss ways to handle membership dues money. Report to be submitted to the Board. President Hueg to determine who will follow up to ensure compliance.

8. Committee progress reports

Each Board member assigned to a committee gave a brief overview of their committee's activities.

Franklin gave a Membership Committee update: the committee would like to add a central valley member; create a state map broken down by chapters; make Zoom available on an ad hoc basis; train committee members on monthly membership reports who can then train chapter presidents. The Membership Committee will discuss how to filter the Membership Report at the March committee meeting. Much of this information will be supplied by our office.

McDonnell gave a Bylaws and Governing Rules (BGR) Committee update: 3 members have experience writing state policies; Louie Espinoza has agreed to take Rachel Mendoza's spot.

CSR 6/22/1: Umemoto, second by Franklin to add Louie Espinoza as a member to the Bylaws and Governing Rules committee. CARRIED

Umemoto reported the Political Action Committee (PAC) will meeting on February 16, 2022, at 1:30 p.m. and Dick Mesa is the vice chair. Also brought up the importance to address our CPAC and IPAC so we are ready to fund as we have a statewide primary and statewide general election to focus on this year.

Herrera's HBC update was brief as the Medicare Direct Contract Pilot Program and subsequent HBC activities were discussed in detail earlier in the meeting.

CSR Financial Operating Results – February 2022

For the month ending February 28, 2022, CSR has recognized a net surplus of \$171k with a budgeted surplus of \$373k for fiscal year 2022.

Based only on February 2022 activity, revenue is on track to exceed budgeted revenue by approximately \$152k. Expenditures are currently expected to come in under budget, which is largely due to restricted activity due to the pandemic.

CSR's cash, money market, and investment balances held at Wells Fargo and Edward Jones on February 28, 2022, is approximately \$5.6 million.
